Hello All members.

First I want to start off by saying thank you and good work to the membership.

The key issue I want to touch on this month is the vehicles.

1- All mechanical issues must be reported immediately to the captain of the day, a chief, or Beth Haubrich

2- Any damaged done to the vehicles must be reported. The vehicles will be inspected daily by the COD and the crew chiefs.

All driver training has been suspending pending the revamping of the driver training program to teach potential drivers how to maneuver the vehicles

A Driver Training Committee was formed to revamp the current driver training process here at BSBRA, the initial task of the committee is to establish the pre-requisites needed to start driver training, then establish eligible trainers and finally create the training itself. The training will consist of classroom lecture along with a hand-on session, test, and road time with EVOC style course. We will keep, Saxon circle, parking in the ambulance bays at HQ, SSH/GH hospitals, 10 calls, and fire scenes. But, we will look to incorporate other task that will get the membership familiar with the district.

For the current drivers, we will start offering EVOC and include the road time session of the training for those who are in need of remediation. This new process is in its early stages and the committee still has a lot of work to go through, so there will be more to come.

Common courtesy call to your captain of the day

We are seeing a rash of last minute call in's, no show-no calls, and members who consistently run late to their duty tours without any notifications to the Captain of the Day. We would like to remind the membership that a call just to give the Captain a heads up would be appreciated as they would be able to help cover that portion of the tour.

For the last minute call in's, it would be common courtesy to give your Captain an ample amount of time to assist in finding coverage. You might be asking yourselves, "What is an ample amount of time?" We are asking that you give a minimum of SIX (6) hours notice. Most people know (in the working world) that they will be calling in within at least that amount of time whether they be sick or just need a mental health day. We feel that the same applies for the volunteer world. We understand that things happen, however, calling in 15-20 minutes after your tour does not help us. We can't even find paid coverage in that time, let alone volunteer coverage. Please have the common courtesies to help the organization.

As far as no show-no calls, we can advise that this is totally unacceptable and it is spoken about way to often in meetings.

Members are also reminded that if you have a regular duty slot and you can not make it, you are to contact the Captain and try to fill your spot. (As per the SOP's). You are responsible for your duty slot, regardless if you are a probationary member, dispatcher, EMT or Driver.

These situations apply to all members, probationary and badge, call-in to interim. When you commit to a slot or to help out someone, please do it. You are giving your word that you will help them out.

Should there be any questions in regards to these requests, please see a Chief.
