It was great to see the turn out at this months general meeting. Once again thank you all for voting me in another term. The turnout was very humbling. A few things to review.

- Social media, I have most of you on Facebook. Be responsible, know the SOP on it.
- OSHA gear , all members are required to use it, badge members are required to use the new gear. Simple, wear it . Any issues please let me know.

- Parades , I want to see all officers and members in the Parade. It's a great time
- Fund raising, let's help out with this stuff. This is for everyone. We should all be part of it, go out and help, any ideas bring it up to Jackie.
- Any Ideas for your day to boost teamwork bring them to the captains or chief so we can review it.
- Vehicles - each day is assigned a vehicle, keep them clean in and out. Ask your Captain of the day which vehicles belongs to the day. This year I'm going to personally inspect the truck, if they are dirty i will have the crews wash it.
- Paramedics will no longer initially respond to Alpha and Bravo calls. The decision has been made to better allocate the departments resources in the most appropriate manner.  
The following will be the procedure for the Paramedics when BSBRA is activated for an Alpha or Bravo alarm:
  - If there is no crew in HQ the paramedic will respond immediately to start patient care.
  - Paramedics will still respond to ALL MVA's
  - Paramedics will still respond to ALL 9/13 (structure fire standbys) signal 4.
  - If activated for an Alpha or Bravo call and a BLS crew is on the road the Paramedic should monitor the "BSBRA OP's" high band radio, and if the BLS crew on scene requests the paramedics response, the paramedic should respond without delay.
- We will be review signal 9 to 2 times.
- QA/QI will be in full effect the up coming weeks.
- Software, the Chiefs office will be meeting with them to finalize and fine tune the system.

## Common courtesy call to your captain of the day

We are seeing a rash of last minute call in's, no show-no calls, and members who consistently run late to their duty tours without any notifications to the Captain of the Day. We would like to remind the membership that a call just to give the Captain a heads up would be appreciated as they would be able to help cover that portion of the tour.

For the last minute call in's, it would be common courtesy to give your Captain an ample amount of time to assist in finding coverage. You might be asking yourselves, "What is an ample amount of time?" We are asking that you give a minimum of SIX (6) hours notice. Most people know (in the working world) that they will be calling in within at least that amount of time whether they be sick or just need a mental health day. We feel that the same applies for the volunteer world. We understand that things happen, however, calling in 15-20 minutes after your tour does not help us. We can't even find paid coverage in that time, let alone volunteer coverage. Please have the common courtesy to help the organization.

As far as no show-no calls, we can advise that this is totally unacceptable and it is spoken about way to often in meetings.

Members are also reminded that if you have a regular duty slot and you can't make it, you are to contact the Captain and try to fill your spot. (as per the SOP's). You are responsible for your duty slot, regardless if you are a probationary member, dispatcher, EMT or Driver.

These situations apply to all members, probationary and badge, call-in to interim. When you commit to a slot or to help out someone, please do it. You are giving your word that you will help them out.

There is also a dedicated Crew Chief on each tour. Please keep them informed as to what happens on their watch, I.e. Rig checks, vehicle issues, crew issues etc, They're also part of the chain of command. We are all eager and our passion is to keep BSBRA moving forward.

As a general note; for any member that comes in to ride whether your tour or not please preform a rig check. That task is not reserved just for probationary members. Badge members should be doing them as well and assisting your crews to preform them adequately. The same goes for daily chores: i.e. Dishes, garbage removal, organization of equipment, etc. If we all use it we are all responsible for it despite our status here.

Running Calls as a crew, everyone please be aware of where you are actually responding, before you depart check with the CAD, the fax, your active911 or the trucks active911. Crews, let's all protect one another and make sure our safety comes first. Your scene safety starts with clicking your seatbelt while going signal 2 all the way to backing in your apparatus after going signal 5, signal 28. Don't take safety for granted.

As a crew, stick together and keep your ambulance in service. Don't walk back to the building from South Side Hospital unless necessary, especially with construction the traffic flow is dangerous at times. Also, for the EMT in charge it is ultimately your responsibility for your PCR and other documentation to be filed and "dropped". PCR's should never be left out in the open for all to view.

We hope you all had an exceptional time at our annual Installation Dinner. For those installed we wish the best of luck to continuing our organizations greatness. Let's all have a great November and we wish everyone and their families a Happy Thanksgiving when the time comes.
