Common courtesy call to your captain of the day

We are seeing a rash of last minute call in's, no show-no calls, and members who consistently run late to their duty tours without any notifications to the Captain of the Day. We would like to remind the membership that a call just to give the Captain a heads up would be appreciated as they would be able to help cover that portion of the tour.

For the last minute call in's, it would be common courtesy to give your Captain an ample amount of time to assist in finding coverage. You might be asking yourselves, "What is an ample amount of time?" We are asking that you give a minimum of SIX (6) hours notice. Most people know (in the working world) that they will be calling in within at least that amount of time whether they be sick or just need a mental health day. We feel that the same applies for the volunteer world. We understand that things happen, however, calling in 15-20 minutes after your tour does not help us. We can't even find paid coverage in that time, let alone volunteer coverage. Please have the common courtesy to help the organization.

As far as no show-no calls, we can advise that this is totally unacceptable and it is spoken about way to often in meetings.

Members are also reminded that if you have a regular duty slot and you can't make it, you are to contact the Captain and try to fill your spot. (as per the SOP's). You are responsible for your duty slot, regardless if you are a probationary member, dispatcher, EMT or Driver.

These situations apply to all members, probationary and badge, call-in to interim. When you commit to a slot or to help out someone, please do it. You are giving your word that you will help them out.

Should you have any questions in regard's to these requests, please see a Chief.

- S4990A/A7668A

Governor Cuomo signed S4990A/A7668A into law on 12/11/15 - "An emergency medical service paramedic or emergency medical service technician may transport any police work dog, as defined in section 195.06-a of the penal law, injured in the line of duty to a veterinary clinic or similar such facility provided, however, that there are no persons requiring medical attention or transport at such time."

NOTE: The new law does not address training, treatment, funding, equipment, existing PD and EMS agencies policies, etc

Happy New Year to All!!!

New Year's is a time of hope for many. Hope for positive change in the upcoming year. I am no different. I hope for positive change as well. Both in my personal & professional life; and my professional life includes BSBRA. With that, I am going to be completely honest in my report this month. Not that I am not honest with each report, but I would like for you all to understand where I am coming from without anyone reading into it, or reading it the wrong way.

I hope that we can all put personal resentments & feelings aside so that we may do the best we can for our community. Not coming down because it is not "your day" or because you do not like an officer of the day, or a crew-member is childish. You stood up in front of the membership that attends general meetings, and most of you stated you "wanted to help/serve the community". Well, serving the community means answering their calls for help, no matter who is in the seat next to you, what day it is, or what the priority of the call is. The 24 rate is slowly increasing, which is disappointing considering the amount of members we have.

I would love to see us start resolving many of our problems, rather than complaining about them to each other in dispatch. Many of us know what the problems are, however, if you do not address them in the general meeting, or in other avenues that are available to you, they will continue to go unaddressed.

Yes, we are a volunteer organization. However, we are a PROFESSIONAL volunteer organization. Therefore, we need to act like it. Dressing in baggy sweat pants on a call is NOT professional. Making jokes that a patient may find offensive is NOT professional. Driving a corp vehicle erratically is NOT professional. The ambulance is a huge mobile billboard! Also, be alert on calls!! Realize that at all times you may be on camera! This is especially true out in the open, such as picking up an intox or an MVA. The public is watching you, don't be the negative example! People also have camera's inside their homes! Treat everyone as you would want your own mother or child to be treated! No matter what their socio-economic status is! The one hour or less that you have contact with a patient or their family may be the most respect they've received in a long time. Be remembered by treating them kindly. Don't be the one that is remembered as "the nasty one", or the "one with the attitude".

Many times in print, things are taken out of context. I do not write this report with anger, resentment or ego. I write this report with the best intentions of the department and the membership at heart. I want you all to know that despite what some people may say about me, or how others may feel about me, I am a fair person. I do not believe in playing favorites, nor do I believe that any day is better than the other. My goal has always been to see us be able to work together, no matter what day it is, or who it is. Joe decided to join BSBRA because he says, "One day I saw an ambulance at Target and I saw people my age helping the person. I always had a passion for helping people so I came down and got an application and joined."

When Joe first joined, his first thoughts were that he was extremely nervous. He says, "I asked myself what did I get myself into? I was very intimidated but I joined on the Monday Crew, the Captain was Gerald and by that time I knew I was meant to be here."

Advice he would give to someone wanting to join BSBRA is that it is very intimidating in the beginning, but there is a light at the end of the tunnel. He also adds, "Keep an open mind, believe less of what you hear and more of what you see with your own eyes."

If Joe had the ability to change something about EMS it would be the precipitation of volunteers because,

"People don't think we have the same trainings as professional EMS agencies. People volunteer out of their own time, and they're away from their families to help strangers."

Some of Joe's proudest moments is when BSBRA won County Agency Of The Year, State Agency Of The Year at Vital Signs and when he won the POT Award.

Goals Joe would like to achieve in the future here at BSBRA is to reunite the membership, make BSBRA the best organization to volunteer at, and to provide hands on trainings for members. He also adds that he also wants to increase the amount of EMT's we have, and to reduce our 24 rate.

Some of Joe's most memorable calls are when it was his first call after being cleared and a guy jumped over the underpass and he got hit by a car. Also when a 3 year old got hit by a car. Joe says, "it really affected me since I am a father but I was there to help him." Then when there was a call for Chest Pains, he said, "Only a BLS crew went and the patient was up and talking then all of a sudden while driving to the hospital the patient coded in the back of the ambulance."

Joe's favorite part about going on calls as a Chief is being able to see members work together and watching them learn and grow, and providing care to the patients.

However Joe would like to say, "I am so proud to be here, there is never a day where I dreaded coming here. As 2nd Assistant Chief I want to provide the best volunteering experiences because personally I think we are the best. I hope to see amazing things happen to the department because we can only go forward from here."
