# Common courtesy call to your captain of the day

We are seeing a rash of last minute call in's, no show-no calls, and members who consistently run late to their duty tours without any notifications to the Captain of the Day. We would like to remind the membership that a call just to give the Captain a heads up would be appreciated as they would be able to help cover that portion of the tour.

For the last minute call in's, it would be common courtesy to give your Captain an ample amount of time to assist in finding coverage. You might be asking yourselves, "What is an ample amount of time?" We are asking that you give a minimum of SIX (6) hours notice. Most people know (in the working world) that they will be calling in within at least that amount of time whether they be sick or just need a mental health day. We feel that the same applies for the volunteer world. We understand that things happen, however, calling in 15-20 minutes after your tour does not help us. We can't even find paid coverage in that time, let alone volunteer coverage. Please have the common courtesy to help the organization.

As far as no show-no calls, we can advise that this is totally unacceptable and it is spoken about way to often in meetings.

Members are also reminded that if you have a regular duty slot and you can't make it, you are to contact the Captain and try to fill your spot. (As per the SOP's). You are responsible for your duty slot, regardless if you are a probationary member, dispatcher, EMT or Driver.

These situations apply to all members, probationary and badge, call-in to interim. When you commit to a slot or to help out someone, please do it. You are giving your word that you will help them out.

Should you have any questions in regard's to these requests, please see a Chief.

# CAPTAIN EDWARD TRIVINO: An Outstanding Member



Edward Trivino first started volunteering at BSBRA in August of 2013. Ed joined BSBRA because he witnessed a good friend get severely stabbed. He says, "I was the first one who ran to help him, I wasn't afraid to approach the situation and help. Not only was this my friend but he was also somebody's son and brother. Why not do the same for others? It all came naturally to help and it wasn't just him, it comes naturally when helping all patients. But his situation was the main reason I joined"

Ed's first thoughts while joining here was that he didn't know what to expect, nor did he know how the system was ran and he was very "intimidated" but everyone was very friendly.

Ed also works as a Mechanical Engineer and at Brentwood Ambulance. Positions Ed has held are Crew Chief and he is currently the Captain for Wednesday's. His favorite part about being a Captain is, "interacting with multiple personalities."

If Ed had the ability to change anything about EMS in general it would be the amount of information that is giving to providers because it is very limited prior to the arrival on scene and sometimes information is given incorrectly. If he had the ability to change anything about the department he would "make sure every incoming member gets a chance to meet members of different days during their probationary period. Often times, members are intimidated when riding on different days. We are a gigantic family and

no one should feel that way."

Ed's most memorable calls was a cardiac arrest on Father's Day. He says, "The little girl was screaming 'Grandpa!' and since I'm a father it really affected me." Another call was another cardiac arrest, "the guy would only respond to my name... Not his own name. It was the craziest thing ever." Finally, there was a little boy who sprained his ankle. "This little boy loved soccer, and I love soccer too. And all this little boy was worried about was if he would be able to play soccer again or not. He was one very cool kid."

Some of Ed's proudest moment are being able to work with all different crews and getting to know all different people and to learn from them. Also being able to give someone a second chance at life. Advice Ed would give to someone joining BSBRA is to learn as much as you can from different people and be open minded.

Goals he'd like to achieve is to continue making a full career change into the EMS field and become a paramedic some day as well as more leadership at BSBRA in the next century. A major lesson Ed has learned is, "every call might be your last. Watch each other's back. It's very easy to not do that. Be safe especially in the world we live in."

But at the end of the day, Ed says.. "Life's not about waiting for the storm to pass, it's about learning how to dance in the rain."






