Common courtesy call to your captain of the day

We are seeing a rash of last minute call in's, no show-no calls, and members who consistently run late to their duty tours without any notifications to the Captain of the Day. We would like to remind the membership that a call just to give the Captain a heads up would be appreciated as they would be able to help cover that portion of the tour.

For the last minute call in's, it would be common courtesy to give your Captain an ample amount of time to assist in finding coverage. You might be asking yourselves, "What is an ample amount of time?" We are asking that you give a minimum of SIX (6) hours notice. Most people know (in the working world) that they will be calling in within at least that amount of time whether they be sick or just need a mental health day. We feel that the same applies for the volunteer world. We understand that things happen, however, calling in 15-20 minutes after your tour does not help us. We can't even find paid coverage in that time, let alone volunteer coverage. Please have the common courtesy to help the organization.

As far as no show-no calls, we can advise that this is totally unacceptable and it is spoken about way to often in meetings.

Members are also reminded that if you have a regular duty slot and you can't make it, you are to contact the Captain and try to fill your spot. (as per the SOP's). You are responsible for your duty slot, regardless if you are a probationary member, dispatcher, EMT or Driver.

These situations apply to all members, probationary and badge, call-in to interim. When you commit to a slot or to help out someone, please do it. You are giving your word that you will help them out.

Should you have any questions in regard's to these requests, please see a Chief.

A few reminders: To cleared drivers: As per the vehicle and traffic safety law, if your lights are on, your sirens should be as well. Use of LUCAS™ CPR Device

Purpose: LUCAS Chest Compression System is to be used for performing external cardiac compressions on adult patients who have acute circulatory arrest defined as absence of spontaneous breathing and pulse, and loss of consciousness. LUCAS must only be used in cases where chest compressions are likely to help the patient.

Scope: Bay Shore-Brightwaters Rescue Ambulance has purchased two Lucas CPR devices. This SOP is intended for all Bay Shore-Brightwaters Rescue Ambulance members.

Definitions:

A) The LUCAS™ Chest Compression System is a **safe and efficient tool that standardizes chest compressions in accordance with the latest scientific guidelines**. It provides the same quality for all patients and over time, independent of transport conditions, rescuer fatigue, or variability in the experience level of the caregiver. By doing this, it frees up rescuers to focus on other life-saving tasks and creates new rescue opportunities.

Procedures:

- A) One LUCAS™ CPR Device will be at all times | the first due ALS Responder (3-24-80 or 3-24-81).
- B) The other Lucas CPR device will be housed in the Vehicle Bays alongside the RAD-57. The second due duty crew or second due ALS responder will be responsible in ensuring that the second Lucas device is taken, if a second alarm goes out and it's use maybe required.
- C) First due ALS provider Paid or Volunteer must ensure that the device is available and ready for use.
- D) Captains of the day must ensure that the second device is available and ready for use.
- E) After each use the device must be cleaned with the appropriate solution to ensure that it has been properly sterilized
- F) Any issues with the device immediately call Paid ALS Supervisor, Captain of the Day and/or any of the Chief's.
- G) All new members and paid employees will be in-serviced by the Paid ALS Supervisor, Training committee, crew chief and/or Captain of the Day.

Do NOT use the LUCAS Chest Compression System in these cases: • If it is not possible to position LUCAS safely or correctly on the patient's chest. • Too small patient: If you cannot enter the PAUSE mode or ACTIVE mode when the pressure pad touches the patient's chest and LUCAS alarms with 3 fast signals. • Too large patient: If you cannot lock the Upper Part of LUCAS to the Back Plate without compressing the patient's chest.
