Dear Members,

On behalf of the Officers of BSBRA, I would like to wish you all a happy, healthy and safe New Year. As we say goodbye to 2011, some may reflect on what a year it has been. The year 2011 has brought us many surprises, as well as many successes. I am pleased to announce that we have had our busiest year ever, topping out over 4,000 alarms and have maintained a 24 rate below 1%. Our success has always been a reflection of our membership, and its dedication to helping the communities of Bay Shore and Brightwaters. Congratulations on another great year, and thank you for all of your hard work!

Now, its time to take a look into the future of BSBRA, and use 2012 as a platform for new endeavors and greater success's. At January's monthly General Meeting, we took a look into some of the goals that have been set forth by the Chief's. These goals are both individual goals as well as organization goals. Regardless of which category, all the goals are for the betterment of BSBRA and its membership. One of the major goals is the continuing focus on the membership with regards to training and retention. As stated in the past, the past 5 years has been spent solidifying the cement that holds the membership together. We believe that we have the strongest walls that any organization can have, and now, it is

time to add that second floor. It is the commitment of this Chief's Office to focus on growing the membership. But, we must first retain the members who have helped us get to where we are today.

As far as issues to discuss, one of the major issues that we are having is the fueling of the rigs and responders. The Captains have all been instructed to make sure the vehicles are fueled before they leave. I understand that there are times that our call volume is very prohibitive of following through with this request. I am asking everyone to please do the rig checks and look at the fuel. If by chance the fuel in ANY vehicle is hovering around half, please take the initiative to bring the vehicles to the town pumps. Monday thru Friday, this can be done between the hours of 0830hrs and 1500 hrs. Weekday evenings and the weekends, you must call Islip Town Public Safety @ 631-224-5300. They will open one of the pumps for you. Please try not to bring all of the vehicles at the same time as this takes the crews out of district for about a half hour.

Rig Checks are to be done before each shift, regardless of position or certification level. The NYS DOH has been around inspecting the rigs, and has been looking for anything and everything. In the event that one of our ambulances is stopped, the Chief's Office would like a call. Please make sure you check the 800 cabinets, and reseal them if necessary. Along with the rig

checks, please make sure you have your Drivers License, and EMT Card on you at all times while on the Ambulance. This is one area that the DOH can inspect, and it is a very expensive fine for both the EMT as well as the organization. Over the next month, Shivannah and Jason will be requesting a copy of all of your certifications including CPR and EMS certifications. It is important that we have the updated information on file. We are asking for your complete cooperation in this matter. Any member that does not comply can have their privileges suspended in this organization. We are also updating all addresses and phone numbers for ALL members. Please make sure you fill out the form, and return it to the Chief's Mailbox.

I would like to again thank you all for your hard work. It's amazing to see the differences between our membership and our surrounding organizations. The Chief's Office looks forward to continually working with all of you and welcomes any suggestions that the members may have.

As this exciting and productive year comes to an end the Chiefs Office would like again to thank you for all you do for BSBRA and all the amazing accomplishments you have brought to the department over this last year. BSBRA has become an organization that is looked up to and mimicked after by other departments across the country. This is because of your professional actions on a day to day basis and your dedication to the department. Each and every one of you are a huge asset to the department and will only continue to be in the years to come. We have come a long way but still have a long way to go with the ever changing protocols and medical treatments, trainings become more intense and we may have more mandated trainings in the future. Please continue to do your best with keeping up on your trainings, meetings, and duty hours. Remember that if you can not make any of required meetings, trainings, or duty hours to fill out excuse forms and communicate with an officer.

Make up trainings.... There was no training in October, so everyone gets a pass for that month. November was the Labor and Delivery training, a make up training is posted online for you to take. Please go through the power point provided on our website. You must print out the test, fill out

an excuse form and submit both the test and the excuse form together to myself. You will have until the end of January to submit an excuse for this training. The December make up training will be out within the next two weeks and members will have until the end of February to submit the make up for the December Head Injury training, by printing out the exam and submitting that with an excuse form to myself.

January training.... I am working with a CLI for the county to teach a core CME training in January. Unfortunately I do not have the dates as of yet but hope to have them by the general meeting and will put out an email with the training dates and they will be posted on the website as soon as I get them. Sorry for any inconvenience.

February training... We will only have one training date for February as we will have a Cardio Thoracic surgeon from Southside hospital coming in to discuss LVAD's. LVAD stands for "Left Ventricular Assist Device". In simple terms it is a mechanical pump that works off of battery power to assist the heart in pumping blood around the body. During this training you will learn what type of patients are candidates to receive this device, EMS providers role in

responding to patients with LVAD's and the physiology behind the LVAD. Southside will soon be placing LVAD's in patients and we will be seeing more patients with LVAD's in our communities. I HIGHLY recommend you try and attend this training! Like I said as the surgeons time is limited we will only have one training date in February which will be Tuesday February 7th at 1900 hours. Should you have any questions feel free to contact me.

CPR. We will be holding the normal CPR refresher classes on Tuesday January 3rd at 1900, and January 18th at 1900. We will also be holding our first CPR class open to the public on Sunday January 8th at 1000 am. If you have any co-workers, friends, or family members who are not in health care and are interested in learning CPR for free please have them go to our website and on our home page click on the "CPR" link on the left side of the screen and fill out the form. They will be taught the heartsaver curriculum where they will learn adult, child and infant CPR as well as AED use. They will receive a CPR card approximately 2 weeks after the completion of the course. Should you have any questions feel free to contact me.

As most of you know we have taken in 4 new probationary members. All of which have completed the 4 required initial trainings. They will now be riding on their duty tours. Please welcome them with open arms, and teach them what BSBRA is all about. The trainings they have completed are CPR, Chiefs Orientation to BSBRA, OSHA, Sexual Harassment, and Ambulance Orientation (basic overview of ambulance operations and patient care in back of the ambulances). The probationary trainings are at 1900 hours every Monday from here on out. We are always looking for a few good members to teach the new probationary members so if you are

interested in helping out and are available during that time please contact me.

Narcotics... We have received our narcotics license from NYS Narcotics Bureau and will soon be carrying the narcotics on the ambulances. The delay is that we are waiting on the software for the safes that have been installed on the ambulances. Once we receive the software Nikki Mongiello (one of our paid medics and our designated narcotic control officer) will contact the ALS providers that have completed the narcotics in service and will give you access to the safes. For EVERY member please ensure to lock the doors of the ambulances even more now then ever!

Lastly the chiefs office hopes you had a great holiday and a joyous new year! A special thank you to those of you who took time away from your families on the holidays to help get the calls covered, your help does not go unnoticed! Once again Happy New Year and we look forward to working with each and every one of you in 2012 to even raising the bar higher in 2012!
