I was also informed that we had a total of 3 ALS crews. Although you didn't get to go at that time, I'm sure you enjoyed the food, courtesy of Gerald. A big thanks does go out to Chris McCann and Joe Jamros. Upon receiving a call from the EMS Coordinator at 0530hrs, I put out an email for a crew. Chris and Joe volunteered their time (10 hrs of it) to go out there and ensured that each and every fire fighter was rehabbed and treated as necessary. At one point towards the end of the day, BSBRA was dedicated as EMS Command for the incident. Great Job to all those who came down and stepped up.

At this point, I would like to go over some house keeping. We, the Officers would like to remind everyone that, as per the by-laws, we are required to re-evaluate Call-In status every three months. We try to give the membership an ample amount of time to get the letters in. To date, we have only approved 9 people for Call-In Status. This means, there are a few of you that do not have any duty slots, nor are you on an alternative status. The following members need to contact a Chief in regards to picking a duty slot.

Although most of the personnel on the list do the hours necessary, as per the by-laws, you must have a steady duty tour. The officers are taking a hard line in regards to giving out Call-In Status from now on. Each re-evaluation will include a look into the "consecutive" hours that you do, and ensuring that you are doing what has been set forth by the by-laws.

With the cold weather approaching, I would like to remind everyone to not park any of the Ambulances' or the ALS responders outside for an extended amount of time. Just recently, the temperatures dropped into the low 40's and 3-24-81 was left outside for 24 hrs. Although it is for the use of the members, 3-24-81 also has ALS drugs in the back of it. It is important to know that the drugs are very expensive to replace and the money spent on replacement could be money spent on something that is needed for the organization.

With the cold weather comes the snow, and ice. We all hope that everyone uses due caution while responding to the building or a call in any vehicle. Remember, whose going to help you if you get into that accident? In the event that inclement weather comes upon us,

the Chief's Office will be keeping an eye on the weather outlooks as well as the current conditions. In the event that a "snow" emergency is called, we will notify the members via email, and through the paging system. We ask that if the roads are that bad you stay here at the building.

Recently, the Officers were invited to attend a "Gangs in your Community" lecture that was held at the BSFD. The training was given by SCPD COPE, and went over the tell tale signs of gang presence in the community. We are all aware that the community of Bay Shore is having its share of problems, mainly around the High School and the Mall. We ask that while responding to VIP's or any assault calls, that you use due caution. Make sure that PD is on scene, and that the scene is cleared. In the event that the scene is not safe, or becomes unsafe, we ask that you pull your crews and vehicles (if able to) out of the scene. No questions will be asked, and you will have the full backing of the Chief's Office in that event.

The Chief's Office also wants to remind you to sign in and out for everything. Trainings, meetings, committee work and duty hours are all necessary to ensure that you are in good standing to vote at the General Meetings. The Eligibility Committee will be meeting on a monthly basis to track any member that might be interested in running for an office next year, remains eligible to do so.

**Finally, on behalf of all the Officers of BSBRA, I would like to wish you and your families a healthy, safe and joyous Holiday Season. We are very thankful to have the membership we do. Thank you for all of your hard work and efforts over the past year.**

Hello everyone, I'm Pete Klopsis, President of the Board here at Bay Shore.

Tonight I would like to take a couple of minutes tonight to talk to you about dedication. A word that we hear quite often in our profession.

Webster's defines dedication as a "self-sacrificing devotion", adequate as definitions go, but it feels sterile, one dimensional, and does not come close to what I have come to understand of the word.

I would like to describe to you two examples of dedication that I have witnessed.

My two sons are in the Boy Scouts, so, several weeks ago, I had the opportunity to go camping and because I was there, it rained.

One of the requirements for the scouts to progress in rank is they each need to cook a meal for their patrol. So, Sunday morning, one of the younger scouts has the task of cooking bacon for the rest of us. A Coleman propane stove was placed on the end of a picnic table that just stood out past the edge of the tarp overhead. A parent started the stove and placed a flat griddle across both burners. I watched the child open the first pound of bacon and promptly drop it into the puddle that had collected under his feet. He picked it up, dried it with a napkin, and placed the entire pound on the now too hot griddle. The grease caught on fire, which startled the child. The parent pulled the griddle off the stove until the fire burned out, removed the burnt bacon, and placed it back on the stove. The scout then opened a second pound of bacon and with new instructions from the adult, began to place individual slices on the griddle. After the third slice, the griddle caught on fire. Again, the parent moved the griddle until the fire went out. The boy then proceeded to find a hesitant balance with the griddle that did not cause a fire.

So the child stood in front of this stove in the rain for 45 minutes, constantly afraid of it catching on fire, cooking one slice of bacon at a time. That is surely a self-sacrificing devotion.

My other example occurred a couple of years ago. At 3am one rainy Sunday overnight, we were called to a heavy rescue involving a plumbing van into a tree. The driver was unconscious and pinned between the dash board and the shelves of equipment behind him. It was a difficult pin job and it took us 30 minutes to extrication him. At one point I was able to step back and look at all the activity surrounding the vehicle. Between my crew, the fire department, the police emergency services, and the helicopter, I counted 22 emergency workers at this scene, struggling in the early morning dark, the noise, and the rain to save this one man; all with the same self-sacrificing devotion.

I must admit. I am moved when I witness this type of intense dedication. I relish it, and I tend surround myself with dedicated people. That is why I am a member here at Bay Shore. The dedication I see every time I go on an alarm calls to me, humbles me, and I am proud to be amongst you.

So, tonight we celebrate this self-sacrificing devotion and I dedicate this night to you.

I've noticed a continued non-compliance on the part of a lot of people as far as wearing the proper uniform on the ambulance. Tons of people (myself included) complained about having to wear the bulky, uncomfortable OSHA gear on every call and the Chiefs/Board heard our complaints. They went out and spent a decent amount of money on Tech Pants for every member to wear, which is what we asked for, so why is it that there are still people that don't have the proper attire on on calls? If you plan on being down at the building for an extended period of time, put your tech pants on. For those of you that are call-in or feel like doing a few pager responses on top of your existing duty tour, well then you're going to have to wear the good old fashion OSHA gear, or keep your tech pants in your locker. If you don't have a locker or tech pants contact Chief Froehlich or your Captain, and we'll try to accommodate you. And yes this DOES go for auxiliary members and members of BSFD, whether you like it or not. If you notice someone wearing inappropriate attire on the ambulance, kindly remind them of the SOP. If they give you further issue, notify an Officer. I would hope that we all have pride in our department, and looking professional is one way of showing it. I know I wouldn't let some of these FD EMS clowns into my house with tie dye shirts, shorts and sandals when my family needs help, so let's be better than them. We ARE better than them.

The Officers as a whole have also noticed a drop in the cleanliness level of the building. If you walk past a garbage that's over flowing, take it out. If you spill something, clean it up. The Officers and other senior members (IE Crew Chiefs) have no problem showing you how something works. Many of us are career EMS providers, and have had contact with a variety of equipment. If you're doing your proper rig checks, the first time you encounter a piece of equipment shouldn't be on scene.

When I first joined this Department 3.5 years ago, a good number of the Captain's had themes for their days and "titles" if you will. There was Tommy's Tuesdays and All-American Mondays and people had pride not only in the department, but in the day that they represented. I'd like to see us bring this back. If you have an idea for a title or theme, let the Captain of the Day know. Especially my Monday people. I'd really like to get a theme going, and get some t-shirts. If we can generate half the pride that people used to have for their day, we can probably even have competitions (friendly ones) between the days.

Saturday's have been going well thanks to all the help and effort that you have all been putting in. It has not gone unnoticed. Saturdays can always use help, especially needing a driver on the overnight and the 1200-1800 shift. If you are able to come down on those tours, please call me.

If you cannot make your tour, it is your responsibility to ensure your shift is covered and the captain of the day is notified.

There has been an increase in messes being left all around the building. With that being said, please make sure you clean up after meals and try to do any dishes that are in the sink. It is not fair for a crew to come in the next day and have to do a sink full of dishes from a tour earlier that day or the night before. We are all a family here and each of us needs to do our share.

If the garbages are full, please take it out and replace the can liner, don't just shove the trash in the can in hopes that the next person will throw it away.

Overnight crews: when you are finished with your tour, please remove the bed linen and place it in the hamper that is in the room.

You are all more than welcome to do your laundry down at the building. However there are a few rules to abide by.

First: For every load of laundry you do, you are required to do a load of corps laundry - one member should not have to do the entire dept laundry.

Secondly : Please be respectful in that there is corps laundry to do, please do not tie up the machines all day doing 5 loads of personal laundry when there are baskets full of corps laundry to do. It's just not fair.

Probies: the probationary rules state that during your probationary period you are automatically placed on the house committee. This means that every week during your tour, you are required to clean one room in the building and have a badge member sign off that you completed your requirement. It takes very little time on your part to clean up a room. This has been very lax recently and needs to be taken more seriously.

Rig check is to be done at the start of your tour and preferably the first 2 ambulances to ensure they are cleaned, stocked, and ready for service.

Spotters are to be used anytime a vehicle is in reverse.




