Dear Members:

IT'S OFFICIAL, 2011 was our busiest year ever. As a team, we answered a total of 4,225 alarms. This includes our normal calls, plus the TAC calls that we responded to. Great job by all members of the organization, and we ask that you keep up the great work!

As we enter the year 2012, we find that there is a lot of opportunity for the organization to grow, both in the membership as well as in the community. This year, the Chief's Office will be taking a different approach by offering trainings geared to the community including first aid and CPR. While teaching and working with the community, we are hoping to increase our membership by 10%, as well as getting our name out there. We are also going to working with our neighboring agencies to strengthening ties and relations, creating a more cohesive work environment.

Last month, the Chief's Office went over our goals for the year 2012. We fully intend on working to succeed in these goals, and will do what we need to do in order to help the organization. We, in turn, would like you all to take a minute to reflect on our goals, and come up with some of your own personal goals. In order to make BSBRA a better place to work (and play), we need to work as a team.

With all this being said, there is always room for improvement on both the part of the leadership, as well as the members. I just want to discuss the upcoming trainings. For the month of January there was no training. I apologize for this as there was a simple miscommunication between myself and the instructor set to do the training. So I will give everyone a pass for the training in January. We also will be giving two department trainings for the month of February. The first training is Tuesday Feb 7th at 1900 hours at HQ. We have someone from Dr. Hartmanns service (Chief Cardio-Throacic surgeon from SSH) coming to do a presentation on the LVAD. The LVAD is a left ventricular assist device. In lament terms it is a mechanical heart. This will be a very informative training by the experts on how EMS should treat patients that have the LVAD. The Chiefs Office encourages all members to attend; probationary members, EMT's, ALS, no matter who you are you will learn a lot at this training.

The second training will be on Carbon Monoxide emergencies. You will be taught how to recognize CO emergencies and how to treat them. We will also discuss how to properly use the RAD 57. The dates will be Weds 2/22 at 1900, and Sun 2/26 at 1200. If you are unfamiliar with CO emergencies and/or the RAD 57 please attend this training.

Both above trainings will be for non-core CME.

The CPR classes and core CME's with Jim are located on our website via the calendar link.

Any member interested in going to a 12 lead interpretation workshop presented by Bob Page on Sat March 31st from 0800-1700 please let me know. There is a \$30 per person fee, I will try and get this covered under our training budget. Bob Page is a great presenter and does an excellent job at teaching us how to read and understand 12 lead EKG's.

An EMT-B challenge refresher is tentatively being scheduled to be held at our HQ starting in June with the NYS test in August. The class will be Tues and Thurs nights from 1900-2200. Jim will be the CIC for the class. I know we have a lot of members set to expire between May and August. I highly recommend that you take this class. We don't like it that you expire but if there is a lapse it is ok, just write a letter to the chief's office so we are aware of such.

To All Members and Paid Employee's
